

General Information

- Licensees are obligated to file and report the returns specified above to TAJ. Returns may be filed online or at any tax office. Returns made require both an eService account and a BGLC account registration.
- Returns filed online are processed overnight and posted to the customer's account.
- Returns are designed to populate from the schedule (inline & online).
- Returns will be subject to line validation and business rules.
- Returns filed at a tax office are received by the cashier then referred to the Returns Processing Unit for data entry.
- The current payment arrangement for contributions to BGLC and CHASE will remain the same.
- Customers must inform BGLC if they intend to cease operations. BGLC will deregister (close) the applicable accounts in RAiS.

What is **RAiS**?

Revenue Administration Information System (**RAiS**) is an electronic platform implemented by Tax Administration Jamaica (TAJ) to facilitate the online administration and payment of taxes.

How **RAiS** will affect you?

As of September 5, 2016, all BGLC licensees who operate gaming machines will be required to voluntarily file returns and pay the relevant levies, duties and taxes using **RAiS**.

Main Features of **RAiS**

- Enhanced online experience
- e-filing of returns
- View account history
- Online payment of taxes
